4. First-aid Measures

4.1 Description of First Aid Measures

GENERAL NOTES: When symptoms persist or in all cases of doubt seek medical advice. Show this safety data sheet to the doctor in attendance.

AFTER INHALATION: Remove person to fresh air. If signs/symptoms continue, get medical attention.

Carbon monoxide, carbon dioxide, nitrogen oxide, cyanides, isocyanate vapours.

5.3 Advice for firefighters

Use water spray to cool unopened containers. Fire will produce dense black smoke containing hazardous combustion products (see section 10). In the event of fire, wear self-contained breathing apparatus. Hazardous decomposition products formed under fire conditions. Collect contaminated fire extinguishing water separately. This must not be discharged into drains.

7. Handling and Storage**7.1 Precautions for safe handling**

INSTRUCTIONS FOR SAFE HANDLING: People handling polyurethane products must have received special training according to guidelines from the National Occupational Health and Safety Board. Persons susceptible to skin sensitisation problems or asthma, allergies, chronic or recurrent respiratory disease should not be employed in any process in which this preparation is being used. Provide sufficient air exchange and/or exhaust in work rooms. Wear personal protective equipment. Do not breathe vapours or spray mist. Avoid contact with skin and eyes. HAND PROTECTION: Isocyanates can harden gloves and increase the risk of their splitting. Protective gloves complying with EN 374: Viton®, Neoprene, Nitrile rubber, Butyl rubber. Gloves should be discarded and replaced if there is any indication of degradation or chemical breakthrough. Take note of the information given by the producer concerning permeability and break through times, and of special workplace conditions (mechanical strain, duration of contact). Be aware that in daily use the durability of a chemical resistant protective glove can be notably shorter than the break through time measured according to EN 374, due to the numerous outside influences (e.g. temperature). Long sleeved clothing. Remove
